A fee of \$1,500 will be received and the following conditions:

The owner(s)/lessee(s) of the bitch agrees:

- To provide a copy of the bitch's pedigree, registration papers, CERF dated within one year, OFA certifications, any other health tests (MDR1, HSF4, etc.) and a current brucellosis test within 30 days (if using live cover).
- Full payment of stud fee and copies of bitch's clearances and a current negative brucellosis test (if live cover) must be received before semen is shipped and/or bitch is bred. If stud owner is open to a possible puppy back in lieu of stud fee the following conditions apply: Bitch owner will pay half of stud fee at time of breeding. Stud dog owner will be allowed to evaluate puppies in person or by pictures and videos when puppies are 8 weeks old. After evaluating the litter, stud dog owner will be allowed to take a puppy of her choosing (2nd pick puppy, after bitch owner takes his/her 1st pick). Stud owner's puppy will carry her kennel name in the puppy's registered name. At that time, stud dog owner will reimburse bitch owner the half of stud fee paid. If stud dog owner

decides not to take a puppy back, bitch owner will pay the remaining half of stud fee before any litter registration paperwork is signed.

- To keep the bitch confined and assure she does not breed with any other dogs.
- To notify the Stud Dog Owner within 24 hours after whelping, or within 1 week of the due date if no litter is whelped.
- To have all puppy tails docked or banded by the age of 5 days. *If tails are left on any puppy without legitimate reason (puppy is sickly, etc.) and written permission from stud owner, stud owners will not sign any litter registration papers and puppies will not be registered.
- To not sell any puppy from this breeding to any puppy mills, pet stores, backyard breeders, individuals who are breeding for mixed breed/designer puppies/dogs or any person who markets their dogs to a wholesaler, retailer, and broker of pets.
- To take back (should the need arise) any puppies from this breeding.
- To provide stud owner with pictures of each puppy within one week of birth and again at 8 weeks old. 8 week old pictures to show each puppy on left side stacked and a front face shot.
- To pay all shipping costs for bitch to/from stud, emergency veterinary fees, and any other fees associated with this breeding (i.e. – A.I. collection and shipping, A.I. fees by veterinarian.) Any reproduction work that requires stud owner to drive bitch or dog to and from vet, trips to airports or to meet bitch owner or agent, bitch owner will be charged 50 cents per mile, round trip. Travel expenses are to be paid within 7 days of each occurrence or upon pickup of said bitch.
- Board for the first 7 days is included in the stud fee. A fee of \$10 per day after that will be assessed. All board expenses are to be paid when bitch is picked up or when leaving premises.
- To notify the Stud Dog Owner of any puppies from this breeding that complete Championship, Obedience, Working, or other titles.
- Provide names and contact information for all show and/or performance puppies sold from this litter upon request.
- No puppies from this litter can be sold outside of the United States without written permission from stud dog owner.

The owner of the Stud Dog agrees:

- To provide a copy of the stud dog’s pedigree, CERF, OFA certifications and any other health testing results.
- To keep the bitch confined and assure she is not mated with any other dog.
- To sign registration papers upon fulfillment of the above agreement.
- That if the litter does not consist of 2 or more live, puppies appropriately marked according to ASCA breed standard, a return service will be given to the same bitch, by the above named stud dog.

***Additional comments:**

There will be no refunds of the stud fee in part or full.

Stud Dog Owner or Agent will not be held responsible for disease, accident, loss, injury, or death to the bitch or to any other person or animal while on the premises or in transit.

By signing this contract both parties agree to the conditions set forth in this contract.
